

Licence agreement for MIS Standards 2022

Condensed version

1. These terms and conditions form a binding agreement (the “**Agreement**”) between the organization, entity or individual (the “**Licensee**”) that wishes to use the Condensed Version 2022 of the Standards for Management Information Systems in Canadian Health Service Organizations (the “**MIS Standards**”) and the Canadian Institute for Health Information (“**CIHI**”), a non-profit Canadian corporation having its head office at 495 Richmond Road, Suite 600, Ottawa, Ontario, K2A 4H6.
2. The Agreement governs the Licensee’s use of the MIS Standards and is effective immediately upon the Licensee’s first use, of any kind, of the MIS Standards (“**Licence Commencement**”).
3. ***The Licensee’s use of the MIS Standards indicates the Licensee’s acknowledgement that the Licensee has read, understood, and agrees to be bound by this Agreement. If the Licensee does not or cannot agree to the terms and conditions of the Agreement, the Licensee may not use the MIS Standards. IF THE LICENSEE USES THE MIS STANDARDS WITHOUT READING THE AGREEMENT, THE LICENSEE IS STILL AGREEING TO BE BOUND BY ALL OF THE TERMS AND CONDITIONS OF THE AGREEMENT.***

Ownership and copyright notices

4. The Licensee acknowledges CIHI’s ownership of the MIS Standards and that CIHI retains all rights in and title to this product.
5. The Licensee obtains no rights in or title to the MIS Standards other than those rights expressly granted to the Licensee by this Agreement.
6. Reproductions of all or part of the MIS Standards made and/or used by the Licensee will employ the following notice to acknowledge CIHI’s ownership of the MIS Standards:

7. The Licensee will not alter, cover or remove any acknowledgement, copyright or other proprietary rights notice placed by CIHI in or on the MIS Standards.

Licence and authorised users

8. a. CIHI grants the Licensee a non-exclusive, non-transferable licence to make strictly internal non-commercial use of the MIS Standards for the purposes of the Licensee's own research, study, and/or data collection and analysis during the term of this Agreement ("**Licensed Use**"). For clarity, as part of the Licensed Use, the Licensee may modify the MIS Standards to adapt it for the Licensee's specific needs provided that the modification does not negatively impact the Licensee's ability to submit data to CIHI as applicable.
- b. For clarity, the Licensee may authorise its employees and permitted contractors under written agreement with the Licensee who have a need to know the MIS Standards to use and reproduce the MIS Standards, in whole or in part, on the Licensee's behalf for the Licensed Use ("**Authorised Users**").
- c. The Licensee will ensure that its Authorised Users are at all times aware of and comply with the applicable terms and conditions of this Agreement. The Licensee will be responsible for the acts and omissions of its Authorised Users as if they were the Licensee's own acts or omissions.

Licence restrictions

9. The Licensee may not:
 - a. access, use or reproduce the MIS Standards outside of Canada;
 - b. provide anyone other than Authorised Users with access to the MIS Standards or to anything that includes or links to any content from the MIS Standards, or sub-license, convey, sell, distribute, or otherwise share the MIS Standards or anything that includes or links to any content from the MIS Standards;
 - c. use the MIS Standards to develop software that will be used for the collection or submission of data;
 - d. use the MIS Standards to support or update software that will be used for the collection or submission of data if the Licensee (or a contractor hired by Licensee for this purpose) developed such software;
 - e. use the MIS Standards for its own research if the Licensee is affiliated with, under contract with, or funded by a commercial organization for the purposes of its research;
 - f. conduct any market research;
 - g. publish the MIS Standards or anything that includes or links to any content from the MIS Standards; or
 - h. use the MIS Standards in a manner that could reasonably be seen as detrimental to CIHI's mandate or operations.

10. Any use of the MIS Standards not expressly and clearly permitted under this Agreement requires CIHI's express, prior, written authorisation under a separate agreement and may, at CIHI's option, require the payment of licence fees.
11. The Licensee may not use or permit the use of the MIS Standards in any manner that could reasonably be seen as competing with CIHI's business in Canada or with any CIHI-licensed software producers.

Breach

12. The Licensee will immediately notify CIHI of any breach or potential breach of this Agreement by the Licensee or its Authorised Users, and the Licensee will take all steps necessary to address and remedy the breach in consultation with CIHI.

Term and termination

13. The term of this Agreement begins at the Licence Commencement and continues until this Agreement terminates in accordance with one of the following termination provisions:
 - a. CIHI may immediately terminate this Agreement by providing the Licensee with notice if any of CIHI's rights in the MIS Standards are lost or challenged;
 - b. CIHI may immediately terminate this Agreement without additional notice if the Licensee or any Authorised User has breached any term of this Agreement and the breach has not been remedied within fourteen (14) days of the Licensee receiving notice setting out the details of the breach;
 - c. CIHI or the Licensee may terminate this Agreement for convenience by providing thirty (30) days' written notice to the other; or
 - d. This Agreement will terminate at any time upon mutual agreement of CIHI and the Licensee.
14. The Licensee will permanently delete or destroy all copies, including but not limited to partial copies, of the MIS Standards in its possession or control, including any copies held by Authorised Users, within 14 days of the termination of this Agreement.
15. The Licensee will not make any use of the MIS Standards after the termination of this Agreement without CIHI's express, prior, written authorisation.

Notice

16. Notice to the Licensee will be directed to the Licensee using the contact information provided by the Licensee, or the individual who acquired the MIS Standards on behalf of the Licensee, in setting up their CIHI profile at www.cihi.ca. The Licensee is responsible for ensuring that CIHI has up-to-date contact information, and the Licensee will promptly provide CIHI with updated contact information by editing the contact information within the CIHI profile or contacting help@cihi.ca as required. The Licensee will be deemed to have received notice from CIHI upon CIHI giving, or attempting to give, notice using the provided contact information, even if such contact information is no longer accurate due to the Licensee's failure to provide CIHI with up-to-date contact information.
17. Any notice to be given by the Licensee to CIHI will be directed to the attention of the Manager, Financial Standards and Information, at the Canadian Institute for Health Information, email_fsi@cihi.ca.
18. All notices and other communications between the parties and related to this Agreement will be in writing.

Intellectual property rights infringement

19. If the Licensee becomes aware of possible or certain infringement of intellectual property rights in the MIS Standards, the Licensee will promptly notify CIHI and use all reasonable efforts to protect those rights.

Disclaimer of warranties

20. THE MIS STANDARDS ARE PROVIDED "AS IS" AND WITHOUT WARRANTIES OF ANY KIND, INCLUDING BUT NOT LIMITED TO WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. THE LICENSEE BEARS ALL RISKS ASSOCIATED WITH ITS POSSESSION, REPRODUCTION AND USE OF THE MIS STANDARDS.

Limitation of liability

21. CIHI IS NOT LIABLE TO THE LICENSEE FOR ANY DAMAGES, INCLUDING WITHOUT LIMITATION, DIRECT, INDIRECT, INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES, EVEN IF CIHI HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGE OR CLAIM, OR IT IS FORESEEABLE. CIHI WILL HAVE NO LIABILITY TO THE LICENSEE FOR ANY DAMAGE OR LOSS OF ANY KIND ARISING OUT OF OR RESULTING FROM THE LICENSEE'S POSSESSION, REPRODUCTION OR USE OF THE MIS STANDARDS (INCLUDING DATA LOSS OR CORRUPTION), REGARDLESS OF WHETHER SUCH LIABILITY IS BASED IN TORT (INCLUDING NEGLIGENCE),

CONTRACT (INCLUDING FUNDAMENTAL BREACH) OR OTHERWISE. THE LIMITATIONS OF THIS SECTION WILL APPLY WHETHER OR NOT THE ALLEGED BREACH OR DEFAULT IS A BREACH OF A FUNDAMENTAL CONDITION OR TERM. IF THE FOREGOING LIMITATION IS HELD TO BE UNENFORCEABLE, THE MAXIMUM LIABILITY TO THE LICENSEE WILL NOT EXCEED THE GREATER OF (a) ONE HUNDRED CANADIAN DOLLARS (\$100 CAD), OR (b) ANY FEES PAID BY THE LICENSEE TO CIHI UNDER THIS AGREEMENT FOR THE MIS STANDARDS DURING THE TWELVE MONTHS PRECEDING THE ACTS GIVING RISE TO THE DAMAGES, EXCEPT THERE WILL BE NO AWARD OF DAMAGES WHERE THE DAMAGES RESULTED FROM THE NEGLIGENCE OR WILLFUL MISCONDUCT OF THE LICENSEE OR ANY AUTHORISED USERS, AS APPLICABLE.

Indemnity

22. THE LICENSEE WILL INDEMNIFY CIHI FROM AND AGAINST ALL CLAIMS, DAMAGES, LOSSES, ACTIONS, AND OTHER PROCEEDINGS, REASONABLE COSTS, AND EXPENSES (INCLUDING LEGAL FEES), HOWSOEVER CAUSED, INCLUDING WITHOUT LIMITATION, BREACH OF CONTRACT, STRICT LIABILITY, TORT (INCLUDING NEGLIGENCE) OR ANY OTHER LEGAL OR EQUITABLE THEORY, RESULTING FROM OR ARISING OUT OF THE LICENSEE'S POSSESSION, REPRODUCTION OR USE OF THE MIS STANDARDS.

Licence fees

23. The Licensee will pay CIHI any licence fees applicable for the MIS Standards as directed by CIHI.

General provisions

24. This Agreement constitutes the entire agreement between the parties with respect to its subject matter and cancels and supersedes any prior oral or written communications, understandings and agreements between the parties with respect to its subject matter.

25. Sections 4, 5, 8(c), 9, 10, 11, 12, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, and 30 (as well as any other provisions which by their nature are to survive) survive the termination of this Agreement and continue in full force and effect.

26. If any part of any provision of this Agreement is held to be invalid or otherwise unenforceable by a court having jurisdiction over this Agreement, the affected part of the provision will be deemed severed from this Agreement and the remainder of the provision will continue in full force and effect.

27. CIHI's failure or delay to exercise a right or remedy or to enforce an obligation under this Agreement will not preclude CIHI from exercising the right or remedy or enforcing the obligation in the future.
28. The Licensee may not assign this Agreement without CIHI's prior, express, written authorisation.
29. CIHI may amend this Agreement in its sole discretion from time to time upon providing written notice to the Licensee.
30. This Agreement will be governed by and construed in accordance with the laws of Ontario and the applicable laws of Canada without regard to principles of conflicts of laws. The Licensee agrees and acknowledges that any dispute arising in connection with this Agreement will be settled by the courts in Ottawa, Ontario, Canada.
