## Train the Trainer

# Staff training

## **Prepare for training**

Prospective trainers will need to know how to access the material as well as understand it so they can present the material effectively, handle questions and manage the session.

Before each session, trainers will need to

- · Characterize the learning audience;
- · Identify their learning needs;
- Create learning objectives; and
- Establish ground rules.

#### Train new staff

Educators can use the resources and learning pathways available to train new staff. They may wish to mirror the course material used in CIHI's education sessions or have participants log in to CIHI's Learning Centre and take eLearning modules. To make training more organization-specific, it can be combined with an organization's software application. Additional case studies are available.

- · Create materials for onboarding new staff.
- Tailor the training to your organization.
- Mirror courses and materials used in CIHI's education sessions.
- Integrate your organization's software application in the training materials.

### Monitor ongoing learning needs

Educators and super-users should regularly check in with staff to monitor ongoing learning needs and identify any challenges. This will provide opportunities to

- Establish an ongoing refresher training series to ensure that staff are up to date with coding guidelines;
- Use data quality and other reports to address areas of concern that may require clarification or more training;
- Ensure that educators and super-users are subject matter experts and are available to mentor staff;
- Share and disseminate information among staff when clarification is required; and
- Leverage the knowledge of educators and super-users by sharing challenging case scenarios with staff.

### **Troubleshoot difficult scenarios**

Be a resource to assist with difficult scenarios and coding questions. Use CIHI's job aids to help code more challenging scenarios and sections. Use eQuery to search for previous answers. - · Complete chart audits at your facility.
- Conduct external competency testing for interRAI tools.
- Review outcome scales and Clinical Assessment Protocols (CAPs) for data quality.
- Review data collection processes for training opportunities.
- View comparable and interactive data in <u>Your Health System</u>.
- View and analyze administrative and clinical data via eReports.
- Review Quick Stats.
